### INVITATION FOR BIDS

The Royal Government of Cambodia (RGC) has received a Loan from the Asian Development Bank (ADB) towards the Technical and Vocational Education and Training Sector Development Program (TVETSDP) it intends to apply part of the proceeds of this ADB Loan No. 3167-CAM to payments under the contract for the **Supply and Delivery of Thirteen Pick-Up Vehicles**.
2. The Ministry of Labour and Vocational Training as Executing Agency (EA) now invites sealed bids from eligible and qualified bidders for the **Supply and Delivery of Thirteen Pick-Up Vehicles**.
3. Procurement will be conducted through National Competitive Bidding (NCB) procedures and under the laws and regulations governing public procurement within the Kingdom of Cambodia.
4. This invitation is open to all eligible bidders from eligible source countries as described in ITB clause 4.
5. Interested eligible bidders may obtain further information from Technical and Vocational Education and Training Sector Development Program (TVETSDP), ATTN: Mr. Hing Sideth, Procurement Officer, [tvproject@gmail.com](mailto:tvproject@gmail.com) and inspect the Bidding Documents at the address given below from **8:00am -12:00 noon and 14:00pm-17:00pm on all working days from 11 November 2015 to 17 December 2015**.
6. Qualification requirements include (i) Documentary evidence of the Bidder's qualification to perform the contract if it is not accepted to the Purchaser's satisfaction, (ii) In the case of a bidder offering to supply goods under the contract which the bidder did not manufacture or otherwise produce, the Bidder has been duly authorized by the goods' manufacturer or producer to supply the goods in Cambodia, (iii) That the Bidder has satisfactorily completed at least two contracts for supply of similar goods in the preceding three years of not less than 50% of the bid price in each contract, (iv) That the Bidder has completed contract work of a total cumulative amount equal to at least two times the value of the bid price in the preceding two years, (v) That the Manufacturer of the offered goods, if a different entity from the Bidder, has experience of at least 3 years in the manufacturing of similar goods and as per the other qualification requirements as per ITB sub-clause 14.2.
7. A complete set of Bidding Documents in English may be purchased by interested bidders on the submission of a written application to the address given below and upon payment of a non-refundable fee USD50 or its equivalent in Cambodian Riel being 210,000. The method of payment will be made by either Cashier's Check or Cash. The Bidding Documents will be sent by post or collected in person at the discretion of the bidder, other than payment of the non-refundable fee specified above; there shall be no other conditions for purchase of the bidding documents.

The Royal Government of Cambodia and/or Development Partner will respectively declare a bidder ineligible either indefinitely or for a stated period of time, to be awarded a contract financed by the Royal Government of Cambodia and/or development Partner, respectively, if it at any time determines that the bidder has engaged in corrupt or fraudulent, coercive or collusive or obstructive practices in competing for or in executing a contract.
